

Notification change of address

Where can this form be used for?

- For moving in Gorinchem
- For moving to Gorinchem from another Dutch municipality
- Emigration

For moving to Gorinchem from a foreign country you need to make an appointment.

For applying for a postal address, you can fill in the form "aangifte briefadres".

When must a change of address be reported?

- Within five days after the relocation. For emigration within five days prior to your departure.
- You can report your change of address up to four weeks before the moving date.

Parking permit

Are you moving to the city center, Dr. Schöyerstraat or Nieuwe Wolpherensedijk? Then you can apply for a parking permit via the online parking portal on our website.

Do you already have a parking permit in the city center, Dr. Schöyerstraat, or Nieuwe Wolpherensedijk and are you moving? You must end this parking permit yourself. Afterwards, you can apply for a parking permit at your new address via the online parking portal on our website.

Incorrectly completing a moving declaration is punishable under Article 4.17 of the Personal Records Database Act (Wet BRP). It is also a criminal offense to register people at your address who are not resident there, for purposes such as receiving higher student grants, higher benefits, or other enrichment. The Personal Records Database Act (Wet Basisregistratie Personen) outlines your obligations as a citizen. The municipality may impose an administrative fine if you fail to provide information or comply with certain obligations.

The fine may vary, but the maximum is €325.

- Copy of signed buying-/rental agreement (only the page with your name, address and effective date)
- Signed consent statement from Poort 6 if you are going to live with someone who already rents a home from Poort 6.
